

**WAIVER AND RELEASE FORM
FOR THE GEORGE FANT DREAM BIG BASKETBALL AND FOOTBALL CAMP

I. PARENTAL CONSENT

I, the parent or legal guardian of _____, a participant in The George Fant Dream Big Basketball and Football Camp (the "Camp"), hereby grants permission for his/her participation in any and all camp activities.

II. ACKNOWLEDGMENT AND ASSUMPTION OF RISK

To the best of my knowledge, my child is in good physical condition and fully able to participate in the Camp. I am fully aware of the inherent and other risks, dangers and hazards connected with my child's participation in the Camp, including physical injury, damage, death or other loss. I am allowing my child to voluntarily participate in the Camp with knowledge of these risks. Therefore, I and my child are assuming and accepting full responsibility for the inherent and other risks (both known and unknown) of these activities, and for any injury, damage, death or other loss suffered by me and my child resulting from those risks and/or resulting from my child's negligence or other misconduct.

III. RELEASE AND INDEMNITY

I, for myself and on behalf of my child, hereby waive, release, defend, absolve, indemnify, and agree to hold harmless, the Camp, George Fant, Chasity Fant, their officers, directors, agents, attorneys, coaches, trainers, medical personnel, sponsors, advertisers, volunteers, other participants, and if applicable, owners and lessors of the premises used to conduct the Camp, against any and all present or future claims, liabilities, suits or expenses (including attorney's fees and costs), whether asserted by me or a third party, for any injury, damage, death or other loss in any way connected with my child's participation in the Camp. I hereby further acknowledge and agree that this Waiver and Release shall be construed in accordance with the laws of the State of Kentucky.

IV. PHOTO RELEASE

I give my consent and permission for the taking of photographs and/or video of my child during the Camp and waive and/or assign any and all rights (including copyright) in such media to the Camp. The Camp, as the sole owner of such media, shall have exclusive rights to control and determine the use, display, performance, reproduction and dissemination of any such photographs and/or videos.

V. UNDERSTANDING

I represent and acknowledge that I have completely read and understand this document and all its terms and all matters referred to herein, and I signed voluntarily as my free act and deed, that I have had ample opportunity to obtain the advice of counsel and that, by signing this document, I understand that I am relinquishing legal rights and remedies that may have otherwise been available to me. I understand that this Waiver and Release shall be construed as broadly and inclusively as is permitted by applicable law and agree that if any portion of this document is held invalid, the remaining shall continue in full force and effect.
